# **Terms and Conditions for Ground Booking**

## 1. Booking and Confirmation

- 1.1 All bookings must be made in advance through the designated booking platform, email, online **www.alhailcricketclub.com** or in-person communication.
- 1.2 A booking is considered confirmed only after receipt of full payment or as agreed with the management.
- 1.3 The ground booking is non-transferable and is only valid for the team or individual who made the reservation.

## 2. Payment Policy

- 2.1 Full payment must be made at the time of booking unless prior arrangements have been agreed upon.
- 2.2 Payments are non-refundable except in cases where the ground is unavailable due to unforeseen circumstances.
- 2.3 Any additional hours used beyond the agreed booking time will incur extra charges.

## 3. Cancellation and Rescheduling

- 3.1 Cancellations must be communicated at least 60 hours in advance to be eligible for rescheduling for friendly matches and for Event 3 weeks in advance.
- 3.2 Rescheduling is subject to availability and may incur additional charges.
- 3.3 In case of cancellations due to weather or ground unavailability, the management will offer a refund or alternate date.

#### 4. Usage Guidelines

- 4.1 The ground may only be used for the purpose specified during booking (cricket matches, training sessions).
- 4.2 Teams must vacate the ground promptly at the end of their booking period.
- 4.3 Music is strictly **not allowed** inside the ground premises.
- 4.4 Commentary is permitted only until 5 PM and must be kept at a low volume to avoid disturbances.
- 4.5 Any damages to the ground or facilities during the booking period will be the responsibility of the booking party and may result in additional charges.

#### 5. Code of Conduct

- 5.1 All participants are expected to maintain discipline and respect towards the ground staff and other users.
- 5.2 Misbehavior, vandalism, or any form of unsportsmanlike conduct will lead to immediate termination of the booking without refund.
- 5.3 Alcohol, smoking, and littering are strictly prohibited on the premises.

#### 6. Equipment and Facilities

- 6.1 The booking party is responsible for bringing their own equipment unless prior arrangements for rental have been made.
- 6.2 The ground's facilities must be used as intended and left clean and orderly after use.

## 7. Liability

- 7.1 The management is not responsible for injuries, accidents, or loss of personal belongings during the booking period.
- 7.2 The booking party is advised to ensure participants have appropriate insurance coverage.

#### 8. Weather Conditions

- 8.1 In case of inclement weather, the management will decide on the usability of the ground.
- 8.2 If the ground becomes unusable due to weather, the booking party will be offered an alternate date or a refund.

### 9. Acknowledgment and Agreement

- 9.1 By confirming a booking, the booking party agrees to abide by these terms and conditions
- 9.2 Non-compliance with any of the above terms may result in penalties, cancellation of the booking, or additional charges.

#### 10. Amendments

- 10.1 The management reserves the right to amend these terms and conditions at any time.
- 10.2 Any changes will be communicated to the booking party prior to their booking date.

### **Release and Indemnity**

By signing this agreement, I assume full responsibility on behalf of my teammates and agree to indemnify all concerned authorities for any loss, damage, or injury to myself or my team's property during play, whether caused by accident, negligence, or any act of persons or equipment related to the event.

I understand that Al Hail Cricket Ground does not guarantee the safety of my equipment or that of my teammates. I acknowledge that this release agreement is binding on myself, my heirs, and assigns.
